Definitions:

In this document, the following words have the following meanings:

- A. "Account" means a monthly PGG Wrightson/Fruitfed Supplies Customer Account or Web Account held by a customer.
- B. "Agritrade" means Agritrade (a trading division of PGG Wrightson Limited).
- C. "Eligible Entrant" means a holder of an Account.
- D. "PGW/FF" means PGG Wrightson Limited and Fruitfed Supplies.
- E. "Prize" means a CarGo 60V EV Tuk Tuk and 2x FFM AgHat Max helmets.
